- 4. Obtain ANSF arrest warrant.
- 5. Encourage reintegration.
- 6. Encourage TLE at NZPRT FOB/COP/FPB.

NZPRT Actions on PID:

- 1. Search individual and vehicle, (with ANP if possible).
- 2. Compel ANP to arrest if illegal items are found.
- 3. Enrol (voluntarily) on ~~PSR(S)2, PSR1~~ (if required) and/or photograph with NZPRT pers. **Biometrics**
- 4. Conduct TLE to answer IR's
 - a. Biographical details, including key locations (place of birth, current residence[s])
 - b. Key associates (including family members), particularly those with links to INS activity or GIROA/ANSF.
 - c. Individual's attitude towards reintegration
 - d. Justification for INS activity
 - e. Details on past/future INS attacks
 - f. Individual's views on CF and GIROA/ANSF
 - g. Contact details, including cellphone number.

NZPRT Effects:

1. Neutralise INS activity through the reintegration process.

Key Tasks:

1. Monitor intentions/activity.
2. BPT obtain ANSF arrest warrant and/or obtain information for JPEL packs on the identification of INS related activity.
3. Support reintegration into the community.
4. Monitor reintegration process progress.

NZPRT Actions on PID:

1. Move individual to group three on occurrence of key task 2.
2. Enrol (voluntarily) on ^{PSR(S)2, PSR(S)} (if required) and/or photograph alongside NZPRT pers. Biometrics
3. Conduct TLE to answer IR's
 - a. Biographical details, including key locations (place of birth, current residence[s])
 - b. Key associates (including family members), particularly those with links to INS activity or GIRoA/ANSF.
 - c. Individual's current attitude towards reintegration (including what GIRoA has provided as part of the reintegration process).
 - d. Individual's views on CF and GIRoA/ANSF
 - e. Information on past/planned INS attacks
 - f. Information on current INS activity, including names, locations and nature of the activity.
 - g. Contact details, including cellphone number.

GROUP 5: NEGATIVE INFLUENCES

NZPRT Effects:

1. Disrupt negative influence through IO and GIRoA.
2. Neutralise individual's intentions/activity through ANSF/GIRoA.

Key Tasks:

1. Monitor negative intentions/activity.
2. Develop releasable GIRoA evidential packs to support arrest warrants for illegal activity.

NZPRT Actions on PID:

1. Enrol (voluntarily) on ^{PSR(S)2, PSR(S)} (if required). Biometrics
2. Conduct TLE to answer IR's as noted in remarks.

GROUP 7: CAPTURED

NZPRT Effects:

1. Identify INS intentions relating to the captured individual.

Key Tasks:

1. Maintain awareness of the release date of the individual
2. Monitor ongoing INS intent/activity/support towards the detained/pending released individual.

NZPRT Actions on PID:

1. Report information on occurrence. If information is obtained that could be used as evidence towards further criminal charges, the information is required to be passed onto the appropriate ANSF/GIRoA officials. If the information that is gained can be used to assist JPEL reporting requirements then this is also to occur.
