Level 0 (Low Risk)

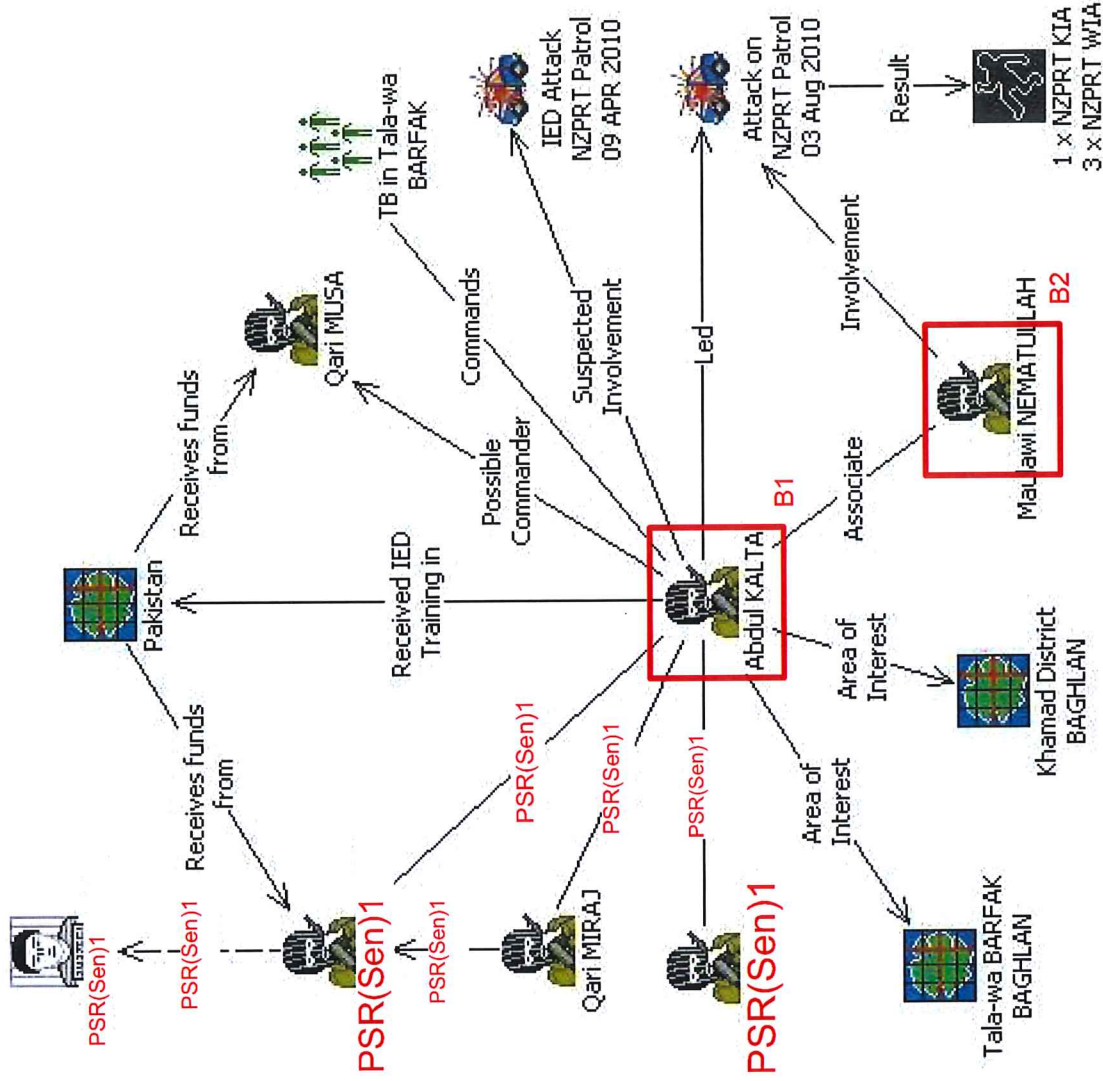
- Day-time deliberate pre-planned forced entry required (progressive 'soft-knock' and 'hard knock'
- Political consequences offer minimum potential of prejudicial IO, media or political impact.

Level 1 (Medium Risk)

- Operations involving entry into houses or compounds at night to include deliberate pre-planned forced entry required (progressive 'soft knock' and 'hard knock'
- May have minor to moderate unfavorable regional media impact, detrimental IO and/or undesirable political consequences, manageable at the regional level.

Level 2 (High risk)

- pre-planned kinetic operations within 10km within 1km of border with Pakistan or Iran
- SOF conducting deliberate operations with company size force or greater within 1km border with Pakistan, or 10km of border with Iran
- Arrest, apprehension, or detainment of any current or prominent former Afghan Government appointed official
- Potential for collateral damage, unfavorable media impact, severely detrimental IO, and/or undesirable political consequences at the national level.

SIGNIFICANCE:

Abdul KALTA is a TB Sub Commander who leads attacks on CF and is involved in TB insurgent activity in Barmyan Province and Barmyan Area of Influence .

EXPECTATION:

PSR(S)2, PSR(S)3

Explanation of wider military effects of Kalta's removal

RISK:

Abdul KALTA has no known links to political or media organizations. Decisive IO needs to be conducted and explained to village elders in the NE Barmyan and SW Baghlan to thwart negative IO messages from INS.

INTEL GAIN/LOSS:

PSR(S)2, PSR(S)3

Explanation of the type of knowledge Kalta had and relative impact of not obtaining this information if he is killed

THREAT STATEMENT:

Abdul KALTA is assessed to have small arms and possibly IED's. He is likely to command 15-20 TB fighters in his village; at this time it is not known how many MAM's are inside his compound, the chance of SA attack is assessed as MEDIUM during the period of darkness and HIGH during daylight hours. HUMINT reports indicate that the Tirigan Village also operates a night guard force conducting armed roving patrols.

ACTIONABLE INTELLIGENCE:

24 total reports: all from Humint, from 11 separate sources, 11 which are graded C3 and above.

PSR(S)2, PSR(S)3

Explanation of the type of knowledge Kalita had and relative impact of not obtaining this information if he is killed

THREAT STATEMENT:

Maulawi NEMATULLAH is assessed to have small arms and possibly IED's. He is likely to command 15-20 TB fighters; at this time it is not known how many MAM's are inside his compound, the chance of SA attack is assessed as HIGH by day and MEDIUM by night. HUMINT reports indicate that the Tirigan Village also operates a night guard force conducting armed roving patrols.

ACTIONABLE INTELLIGENCE:

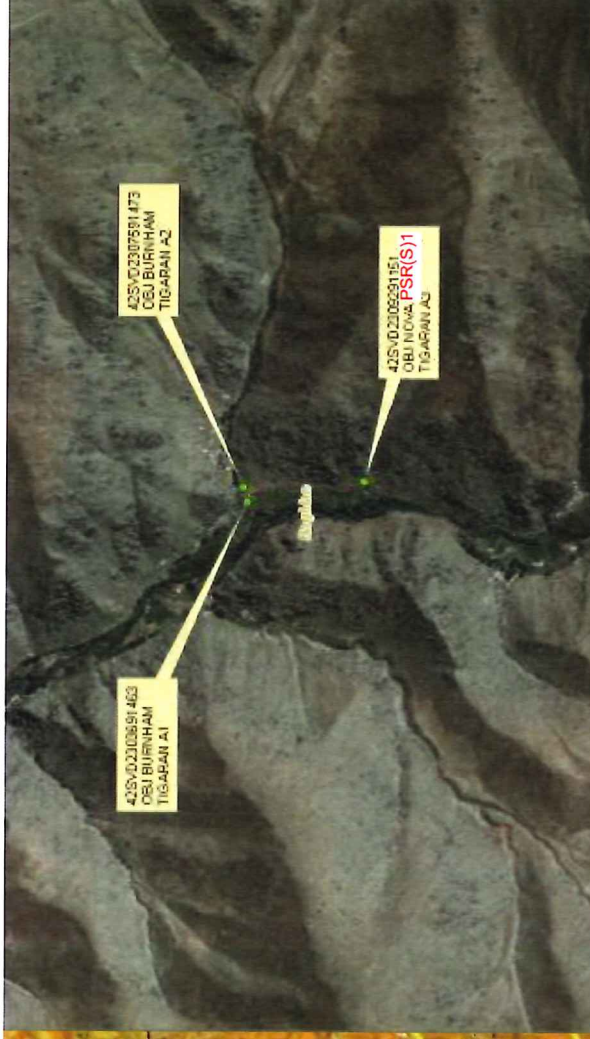

METHOD:

HUMINT TRIGGER, **PSR(S)1, PSR(S)2, PSR(S)3**

HAF INFIL BY NIGHT OF ASSAULT GP, C2 AND OVER WATCH POSITIONS. ISOLATE THE COI PRIOR TO ASSAULT FORCE CLEARING COI AND DETAINING POI. RAPID TSE WILL BE CONDUCTED PRIOR TO BACKLOADING DETAINED POI AND MOVING ONTO SUBSEQUENT OBJ. SEQUENCE OF EVENTS FOR PROSECUTION OF SUBSEQUENT OBJ REMAINS THE SAME AS PREVIOUS OBJ. EXFIL WILL BE BY HELO.

ENDSTATE:

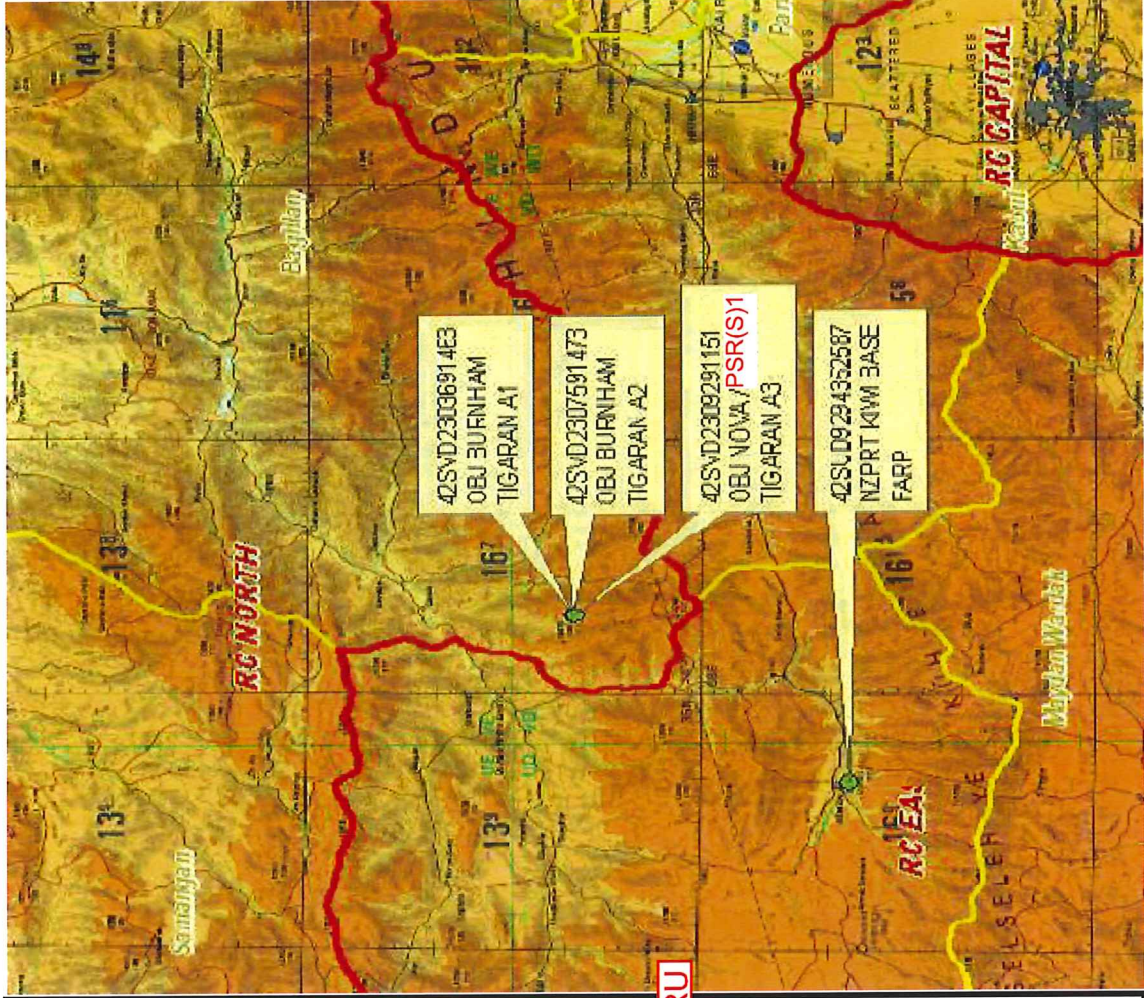
OBJ BURNHAM DETAINED, TSE COMPLETE, TU RECOVERED TO CW AND ^{PSR(S)1, F} HQ, **[CRU]** INTACT AND POSTURED FOR FUTURE OPERATIONS.

SCHEME OF MANOEUVRE:

- PRELIMS: CONFIRM POI IN BDL. STAGE **CRU** TO CW
- PHASE 1: MOVE TO OBJ A1 AND A2. CORDON AND CONTAIN.
- PHASE 2: DETAIN POI AT A1 AND A2.
- PHASE 3: DETAIN POI AT A3
- PHASE 4: TSE AND BSHO
- PHASE 5: RTU KABUL

SUMMARY OF EXECUTION:

ON RECEIVING CONFIRMATORY INTEL, THE TU WILL STAGE FROM CW AND DEPLOY TO THE TARGET AREA IN ORDER TO CONTAIN AND ISOLATE COI AND CLEAR IOT DETAIN POI. COI WILL BE SEARCHED AND ITEMS OF INTEREST EXPLOITED. MAMS WILL BE DETAINED BY **CRU** TRANSPORTED TO MOI HOLDING FACILITIES FOR DETAINMENT PROCESSING. TU WILL CONDUCT BSHO PRIOR TO EXFIL TO KABUL.





SOM / ACTION ON TARGET

INSERTION:

Insertion will be conducted from CW by Helo with simultaneous insertion of HAF and Overwatch posns. HLZ will be secured by blocking force who will orientate N down the valley. **PSR(S)1, PSR(S)2, PSR(S)3**, while ISR and AC-130 will be over target.

ACTION ON TARGET:

Aslt Force will move by foot to TIGARAN 1 and TIGARAN 2. POI 1 will be detained and exploitation conducted. Aslt Force will then move to TIGARAN 3, repeating process. Throughout operation overwatch position will provide cover and overwatch as required. Detainees will be processed by **CRU** and COI exploited. Aslt force will wdr back to HLZ where blocking force is providing security.

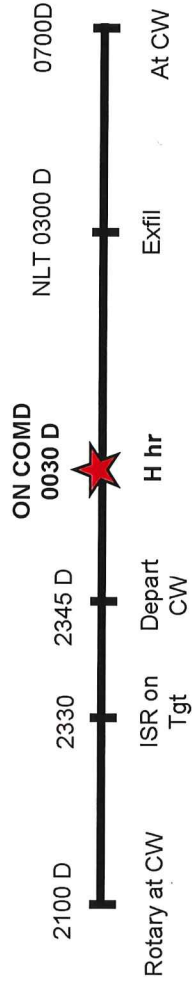
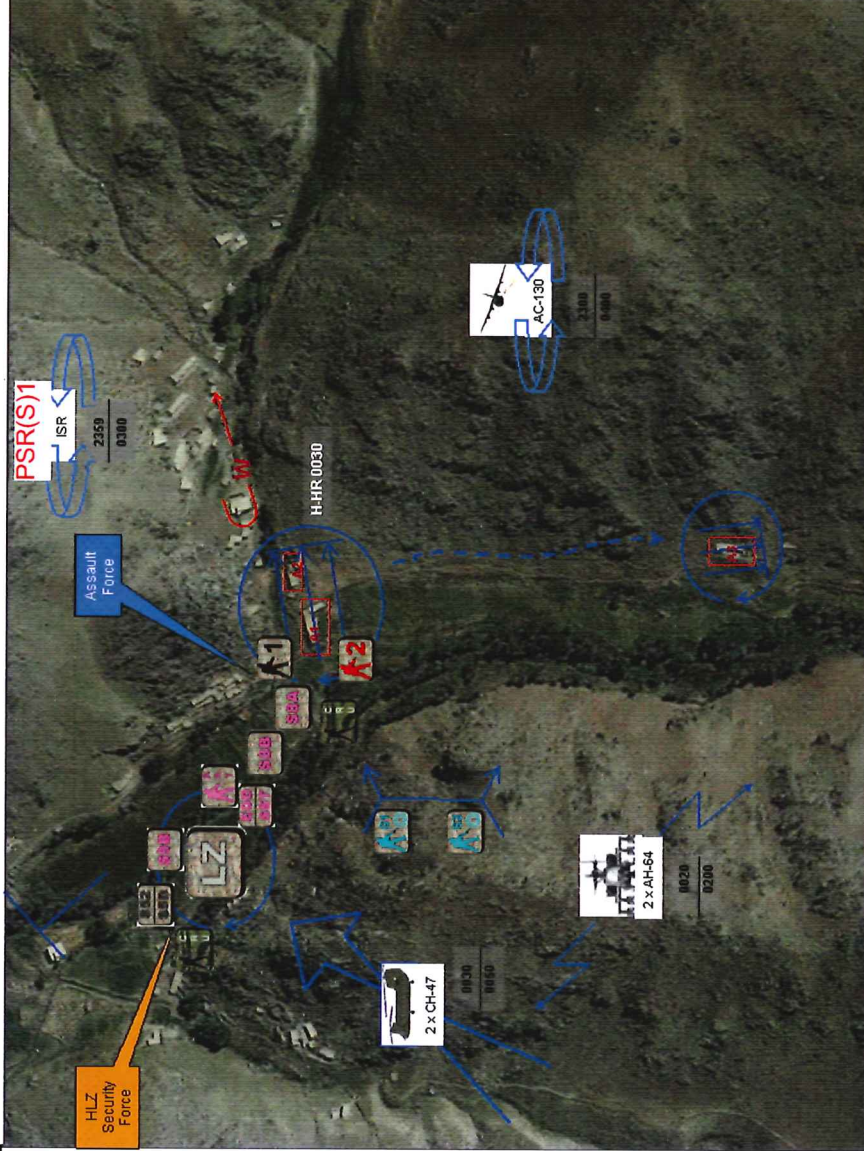
EXFIL:

HAF exfil will occur sequentially from HLZ with overwatch providing cover throughout, before being withdrawn themselves. AWT will remain on station with ISR to provide over watch throughout exfil to KABUL. All detained Bravos will be processed by MOI on return to KABUL.

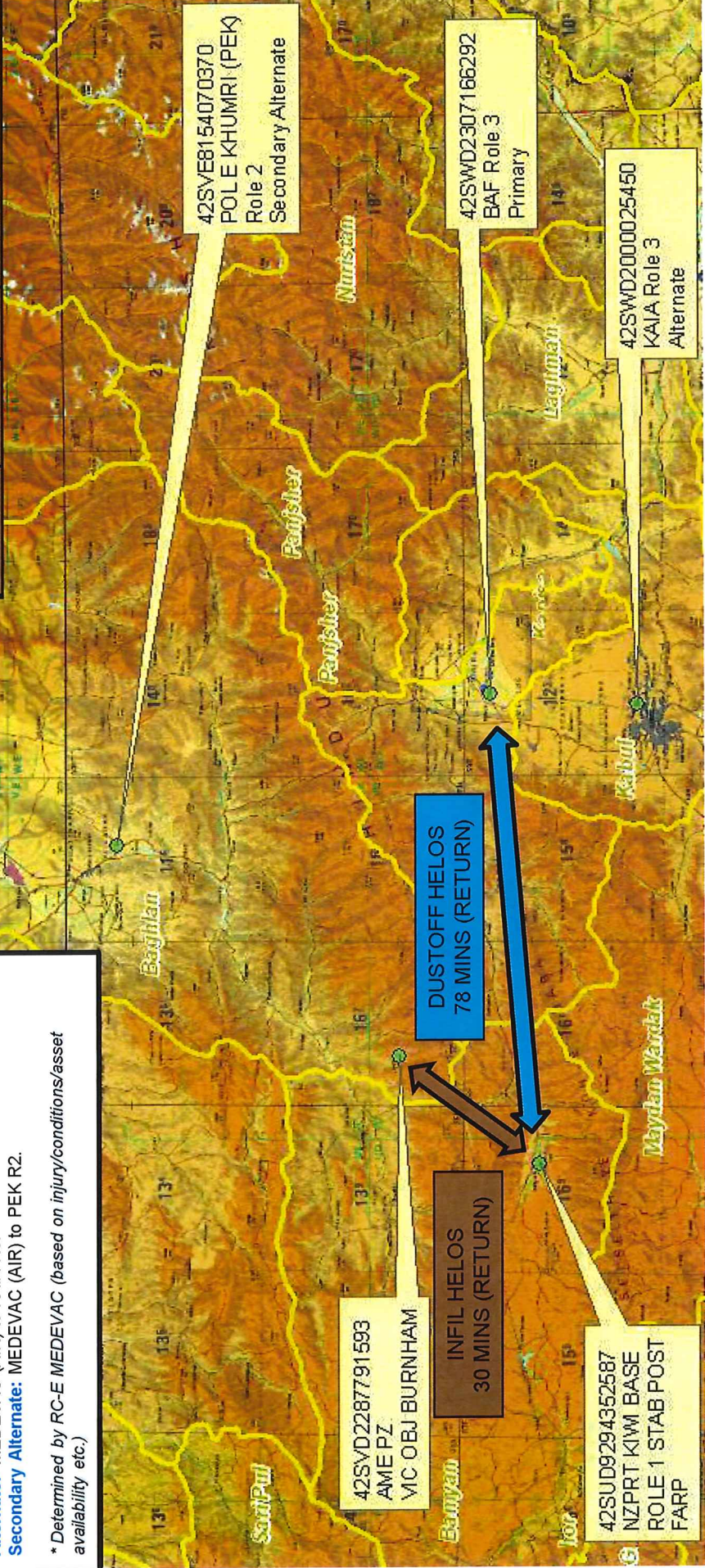

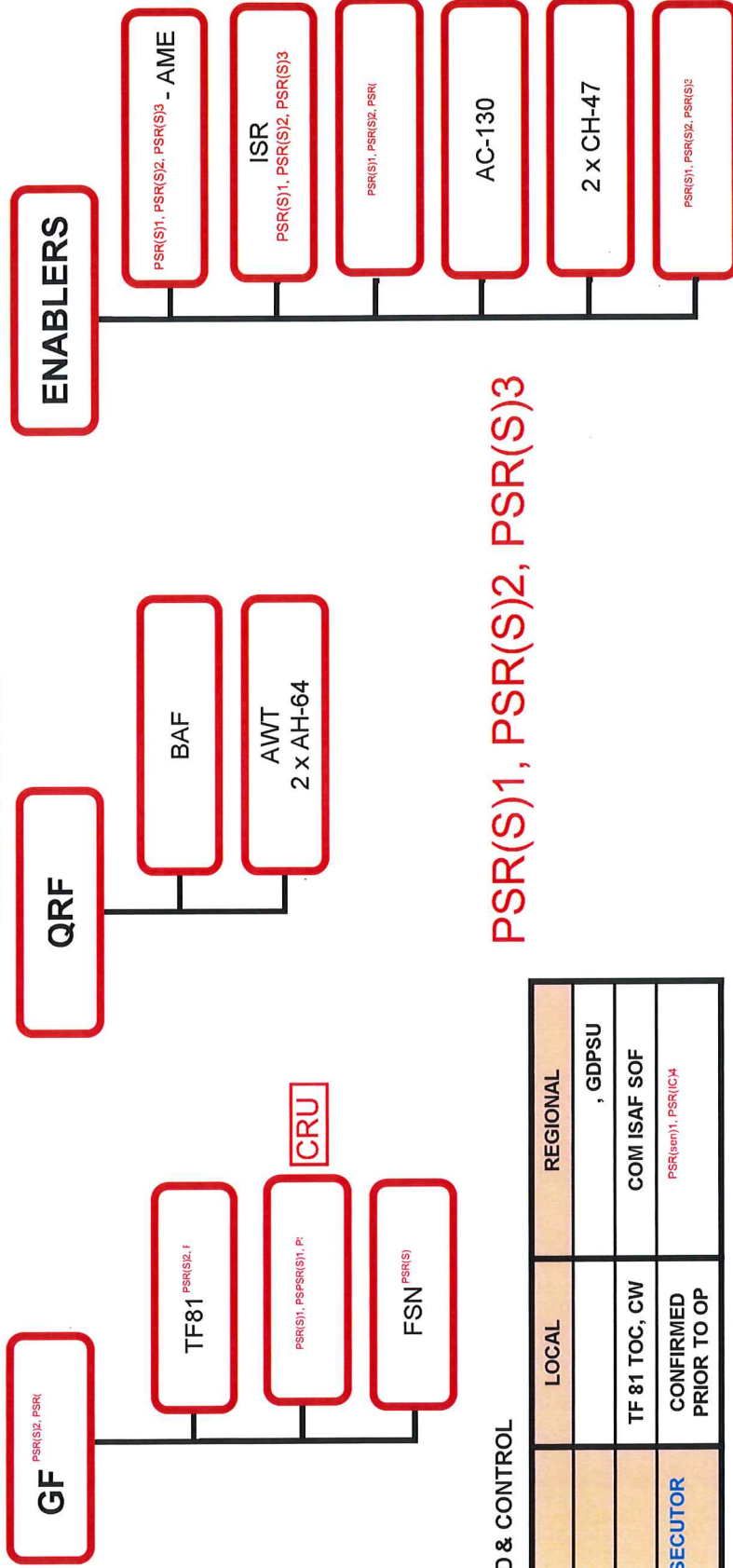

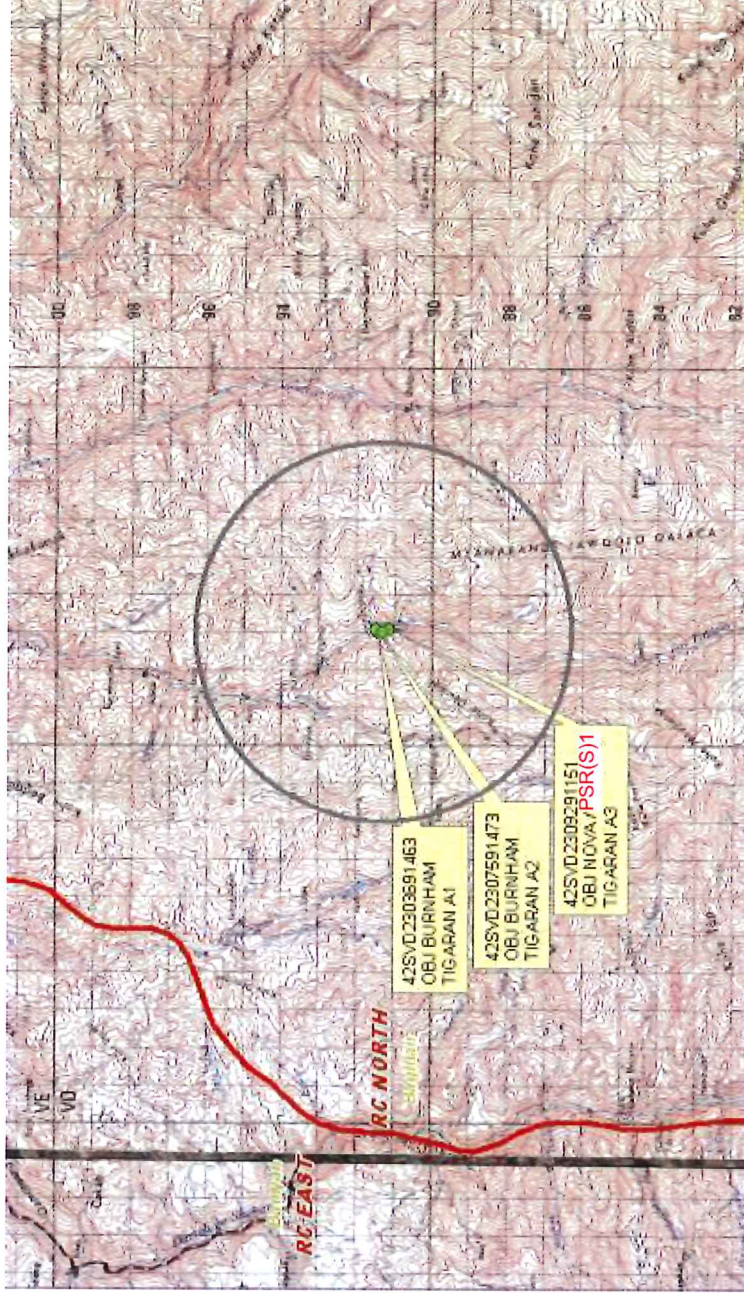
